The Addison County Regional Planning Commission will hold two public hearings, the first on June 13th, 2018 at 7:00 p.m. at its offices at 14 Seminary Street in Middlebury, the second on July 18th, 2018 at 7:00 p.m. at the same location on the proposed amendment to and re-adoption of the Addison County Regional Plan. These hearings are being held pursuant to 24 V.S.A. § 4348.

The Addison County Regional Plan is used as a basis for guiding planning efforts in the Addison Region. For major development applications, certain sections are used as review criteria in Act 250, Section 248 and other state regulatory proceedings. All areas within the jurisdiction of the Addison County Regional Planning Commission are affected. The Addison County Regional Planning Commission proposes to make amendments to the Energy Sub-section of the Plan. It also proposes to re-adopt the entire Plan as amended.
