2009 Transportation Enhancement Program

The Vermont Agency of Transportations Enhancements Program is a funding source for transportation-related activities in Vermont such as new sidewalks, bike paths, historic preservation, environmental mitigation and more. The program's goal is to create a multi-modal and environmentally sustainable transportation system that encourages non- motorized use, enhances Vermont's historical landscape, and promotes a human scale of development. All local authorities, not for profit organizations and federal/state agencies are eligible to apply by submitting a pre-application letter by June 16, 2008. This is a first step in the application process. VTrans will sponsor two informational workshops on June 23 and June 25 about the application process. Attendance at one of these workshops is mandatory for new applicants or those that did not attend a workshop last year. All are encouraged to attend. The workshops will be offered throughout the state via Vermont Interactive Television. Final and complete applications are due on August 26. ACRPC is happy to work with you to apply to the enhancements program. This is not a grant but a reimbursable program and must follow Federal Highway Administration rules. Small Community Sewage Solutions Conference, June 4

Local decision makers, technical experts and state/regional policy makers from New England will meet on June 4, 2008 to discuss sewage treatment options for villages and growth centers. More than 200 Vermont Villages lack any kind of community sewage treatment facility. Without sewerage, options for housing and economic development are severely limited and Vermont's goal to promote compact growth in established centers remains difficult to achieve. Potential pollution problems also exist. Choose from 14 workshops ranging from wastewater basics, to technical presentations, to small town case studies. Learn by seeing at the Wastewater Training Center Demonstration Site at VTC. The conference will be at Vermont Technical College in Randolph. \$60/person includes lunch and refreshments. Why Create A Capital Budget for Local Roads?

prioritize capital expenditures over a specific timeframe. A capital budget can help public officials and citizens anticipate future service problems before the better solutions disappear or become very costly because of nearsighted choices made earlier. And a capital budget can go a long way in helping to make decisions at Town Meeting--a capital budget helps assure citizens that officials have reviewed each item and that valid reasons exist for expenditures. These reasons, articulately presented at Town Meeting, demonstrate that the town has done its homework, and citizens are more likely to respect the recommendation.

There is not one right way to create a Capital Budget. They come in many forms, from simple to complex, and each town must decide what degree of capital budgeting will meet its needs.


You can create a Capital Budget by following this Basic 5 Step Process:


- 1. Inventory. Inventory the equipment, buildings and facilities utilized by the road department. Include assessment of condition, adequacy, and expected life. This includes roads, bridges, culverts, etc.
- 2. Identify future needs. After evaluating existing inventory, project out future needs. These may stem from the replacement, renovation, or repair of existing facilities, infrastructure, or equipment, new services or improvements or additional responsibilities.
- 3. Define each need as a distinctive project. Once needs have been defined, describe the project in detail. Including all aspects of the project.
