The Census is Coming!

On April 20, 2009, U.S. Census employees will begin visiting every community in Vermont during the first major field activity in preparation for the 2010 Census. By visiting addresses in every community, the Census Bureau will know where to send questionnaires and enumerators in 2010. Using hand-held computers, Census employees will walk through your community to identify the location of every housing unit. Address canvassing in Vermont will begin April 20, 2009 and end July 2, 2009. Your cooperation and patience are appreciated.

The Census: A Snapshot

What: The census is a count of everyone residing in the United States.

Who: All U.S. residents must be counted—people of all races and ethnic groups, both citizens and non-citizens.

When: Census Day is April 1, 2010.

Why: The U.S. Constitution requires a national census once every 10 years. The census will show state population counts and determine representation in the U.S. House of Representatives.

How: Census questionnaires will be delivered or mailed to households via the U.S. mail in March 2010. Census workers will visit households that do not return their questionnaires.

2010 Census Timeline: Key Dates

Spring 2009: Census employees go door-to-door to update address lists nationwide.

Fall 2009: Recruitment begins for census takers to support peak workload.

February-March 2010: Census questionnaires are mailed or delivered to households.

April 1, 2010: Census Day.

May-July 2010: Census takers will visit households that did not return a questionnaire by mail.

December 2010: The Census Bureau delivers population counts to the President.

VELCO Long Range Transmission Plan Meetings

A series of public meetings to discuss the draft 2009 Long Range Transmission Plan will be held throughout Vermont. This document is a technical analysis, looking out 20 years and updated every three, that identifies where electricity load growth will require transmission upgrades, new generation or increased energy efficiency to maintain reliability. The public process will provide an opportunity for individuals and entities interested in Vermont's electric transmission system to understand and potentially influence the future of that system by sharing information about activities that may influence future electricity transmission needs, projected peak load and/or potential solutions. Transportation Enhancement Project Funding & Paving Grants for FY09 & FY10 Available

The Vermont Agency of Transportation recently announced the availability funds for the enhancement-type projects. The first round of available funding is for the 2009. \$3.77 million has been set aside for projects that will have final construction plans and bid documents ready by 11/15/09. The application deadline for these project funding applications is May 15, 2009. Generally speaking, the successful project candidates will have design plans, the necessary permitting, and right of way in place by the November deadline. The project maximum is \$300,000, and a 20% local match (with no more than 10% in-kind match) is expected.

The second round is for the 2010 fiscal year and includes 2.77 million of available funding. This will follow the traditional enhancement requirements, cycle and process. The application deadline for this program will likely come in mid-to-late summer. This program does not directly use ARRA stimulus funding, so it does not have the short deadlines and significant restrictions and oversight that go with stimulus funding.

In addition to Enhancement funding, a Class II/Class III paving grant program is available as well. The criteria and deadlines are the same as those listed in the 2009 Enhancement funding listed above. Eligible projects will have a total project cost falling between \$375,000 and \$937,000; with a minimum local match of

\$75,000 and a max of \$187,000. The program includes those projects designed to address the top 2 inches of overlay...this does not include reconstruction projects. The only road classes eligible are Rural Major Collectors or above. The towns must be able to commit the local match funding in writing by 1-15-2010. These projects must be completed during the 2010 construction season.

Transportation Study Underway in the Western Corridor

Over the past 18 months Addison Regional Planning Commission has been partnering with the Vermont Agency of Transportation, the Chittenden County Metropolitan Planning Organization, and the five Regional Planning Commissions in western Vermont to develop a strategic transportation plan.

This plan will identify effective ways to improve the safety and efficiency of the transportation system in a coordinated and balanced manner throughout western Vermont over the next 20 years. Recommended strategies are expected to promote economic vitality in the region while maintaining Vermont's unique and valued quality of life. The plan will develop strategies that enhance the quality of life for communities along the Western Corridor and support the region's economy through transportation investments. Public input will be sought through public meetings planned for each of the five planning regions in Vermont's Western Corridor as well as at the Vermont Agency of Transportation in Montpelier.

Grants

Energy Efficiency and Conservation Block Grant Program

The American Recovery and Reinvestment Act of 2009 provides a significant amount of funding directly to states and municipalities through the EECBG to help them address the following objectives:

1. Reduce fossil fuel emissions;
2. Reduce total energy use;
3. Improve energy efficiency in the transportation, building, and other appropriate sectors.

AARA provides \$3.2 Billion in national funding for EECBG, to be divided as follows:

- 1.9 Billion to be distributed by formula to “eligible local governments” through the Department of Energy
- \$784 Million to be distributed by formula to States
- \$56 Million for a national competitive grant program to be administered by DOE that will give priority to small states (with populations of less than 2 million)
- \$400 Million for a national competitive grant program to be administered by DOE

Funding and Eligibility Breakdown for VT:

- DOE will make a direct allocation to each of the 10 highest-populated cities/towns in VT;
- DOE will make a direct allocation to the State of VT, which will be required to pass not less than 60% of its block grant funding to local governments that are noted slated to receive formula funding directly from DOE; and
- All VT communities that did not receive a formula allocation from DOE or the State of VT may be eligible to apply for funding through one of the national competitive grant programs; at least one of these programs will give priority to small states like VT.

DOE is working to publish guidance regarding how they will administer the program and provide specific instructions on how to apply for funding. For further updates, you should consult http://apps1.eere.energy.gov/wip/block_grants.cfm or call 1-877-337-3463.

Municipal leaders in communities that are interested in receiving funding should begin planning now. This includes generating project ideas, assessing costs, and determining priorities, so you are ready to use the funds effectively and quickly when they are disbursed. Block grant funds can be used to conduct energy audits, make efficiency improvements, retrofits, develop infrastructure like bike lanes and pedestrian paths, renewable energy installations on governments buildings, LED street lighting, and much more.

Green Energy Development Fund Awards

Governor Jim Douglas announced yesterday that the Department of Public Service (DPS) will award \$2.57 million from the Clean Energy Development Fund (CEDF) for renewable energy projects throughout the state. The goal of the CEDF is to increase the development and deployment of combined heat and power (CHP) technologies and renewable energy generation. “These awards will help our state as we continue to expand our efficiency and renewable energy efforts from funding through the American Recovery and Reinvestment Act,” the Governor said. The DPS received 39 proposals seeking \$5.3 million in funding, in response to the CEDF grant solicitation issued in January. The following projects were selected for grant awards:
